## 2024 Shipped Cooled Semen Contract

97%**, who will henceforth be referred to as “Stallion”.

### **BOOKING FEE**

In order for the Owner to reserve a breeding to the stallion, a booking fee of \$250 must be paid upon execution of this Agreement. Booking fee shall be applied to the stud fee, and is not refundable under any circumstances.

**\*\* ALL FEES MUST BE PAID PRIOR TO SHIPPING SEMEN – NO EXCEPTIONS. \*\***

\*\*Should the above named stallion die or become unfit for service, the mare owner will be refunded in full or offered services to a different stallion. \*\*

### **Parties to the Agreement**

The Wild J Ranch (WJR), agent for the above named stallion, will henceforth be referred to as “Stallion Owner” or “WJR”.

The owner of the Mare listed below shall henceforth be referred to as “Owner”.

### **Mare Information**

Owner certifies that he/she is the legal and registered owner and has the right to enter into this Agreement to breed to WJR’s stallion. The following described mare shall henceforth be referred to as “Mare”

**\*\*A copy of the mare’s registration papers and photos (front, sides, rear) clearly showing mare’s conformation is required with this contract. \*\***

## **OWNER ACKNOWLEDGES AND PROVIDES AS FOLLOWS:**

1. Stallion Owner's sole responsibility under this Agreement is to provide semen of the chosen Stallion;
2. The semen provided under this Agreement shall only be used to inseminate the Mare identified herein. Owner agrees that he/she shall not, directly or indirectly, use the semen provided herein to inseminate any other mare. This is a material consideration of the Stallion Owner entering into this Agreement and is required to maintain the quality of foals bred by the Stallion;
3. The "breeding season" begins April 1st and ends on August 15th of each calendar year;
4. The breeding fee covers only one (1) live foal
5. Owner shall not use, obtain or retain any unused Stallion semen for any purpose whatsoever. Owner shall not cause any transfers of embryos from Mare without WJR's prior written consent.

## **COLLECTION & SHIPPING**

Stallion Owner shall ship cooled semen ONLY to Owner's designated veterinarian.

Mare Owner, in conjunction with their veterinarian, is solely responsible for communicating the needed timing of shipment from the Stallion Owner. **The WJR must receive notice of desired collection and shipment by 10AM the day BEFORE the collection is to be made. This means if you need semen for a Tuesday insemination, you will need a Monday Collection, which will require you to give notice before 10AM on Sunday.**

## **COLLECTION & SHIPPING DAYS**

Collection/Shipping days for Cooled Semen shall be Monday, Wednesday and Friday only, for delivery on Tuesday, Thursday, and Saturday only.

Semen will be shipped Fed Ex or UPS - Priority overnight delivery, which generally arrives by Noon the following day.

No warranty, express or implied, shall accompany the Cooled Semen transferred under terms of this Agreement. Mare Owner acknowledges that Stallion Owner cannot guarantee delivery within a certain time period, nor that the Cooled Semen will safely reach the insemination destination without losing some of it's' integrity or quality.

A contract for Cooled Semen does not guarantee that Semen will be available on the day you submit your request. All requests for Shipped Semen will be filled as received, subject to availability.

**SEMEN ORDER CANCELATIONS:** Any Cancellation not made before 10am MST on shipping morning will be subject to a processing fee of \$100.

Orders canceled after the stallion has been collected will be billed in full.

**SHIPPING CONTAINER** must be returned unless otherwise stated. A tracking number for return shipping on the shipping container is appreciated.

## **COOLED SEMEN HANDLING**

Mare must be inseminated within 48 hours after collection of the Semen by a licensed veterinarian or technician. Please note that calculation of the 48 hours begins at the time of collection, NOT the time of receipt/delivery of the Semen at the insemination destination. The WJR in its sole discretion may refuse to ship semen if The WJR believes the insemination is not proper or the Mare is not healthy.

## **LIVE FOAL GUARANTEE: DEFINITION**

Stallion Owner guarantees a live foal with this contract as defined below. If a live foal does not result from the initial or subsequent insemination attempts (limited to the current and following breeding seasons), Stallion Owner will refund the stud fee in full. **All collection and shipping fees are non-refundable, regardless of the result of the insemination attempts.**

### **Definitions**

1. "Birth" is defined as the time the foal has completely left the body of the Mare, and the umbilical cord has been broken.
2. "Live Foal" shall be defined as a foal that stands and nurses from the Mare, or has been fed by hand, within 24 hours from the time of birth.

## **RE-BREEDING**

If the initial insemination attempt does not result in a live foal, Mare Owner will be entitled to subsequent shipments of cooled semen for the purpose of inseminating the Mare (or a substitute mare if approved by the Breeder) to the Stallion in the current and following year's breeding seasons ONLY, if all the below conditions are met. (1) 60 days after insemination the mare is barren; (2) Mare aborts; or (3) the delivery is not a live foal. Under any of these conditions, Owner shall, within 7 days of any of the above events, at their expense, have their veterinarian certify the identity of the Mare, verification of stillbirth, loss of pregnancy, or a non-living foal, with reasonable certainty and backup records so that Breeder may authenticate the veterinarian's conclusion. If Breeder is satisfied, in its sole discretion, with the veterinarian's conclusion, Owner will be entitled to a subsequent shipment of cooled semen. All conditions of this contract will apply to the subsequent shipments of cooled semen. The cost of Collection and shipment fees (as listed above) shall be borne by Owner, and are due prior to shipment being sent.

## **BREEDERS CERTIFICATE**

To obtain a "breeders certificate" mare owner must notify Stallion Owner of the Foals birth and all conditions of this contract must have been met as well as all fees paid in full.

## **WAIVER OF CLAIMS AND INDEMNITY**

The WJR will use reasonable efforts to ship semen on a first call, first serve basis to the designated location. Mare Owner acknowledges that this Agreement does not guarantee semen will be available. The WJR makes no representations or warranties, expressed or implied, regarding the semen delivered under this agreement, including without limitation, representations or warranties that the semen will safely reach the insemination point without losing its integrity, quality or other characteristics. The WJR makes no representations or warranties, express or implied, regarding the delivery of the semen under this Agreement, and shall not be responsible for delayed, lost or mishandled deliveries. Semen will be collected only on established breeding days and no representations or warranties are made or implied that the semen will be available at the time requested by Mare Owner.

**LEOPARD GUARANTEE**- If approved, your stud fee will be refunded if you don't get a leopard/near leopard. Collection, shipping and vet fees are not eligible to be refunded in any circumstances.

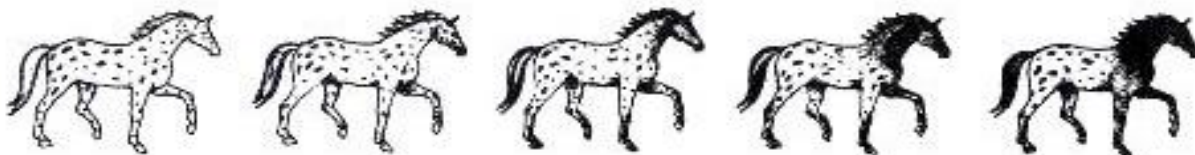
We guarantee a Leopard/Near Leopard foal at birth when breeding to any mare that is:

- Non-characteristic Appaloosa (APHC) that has been genetically tested and is negative for LP gene
- Other breed without white modifiers (such as: Tobiano, Overo, Sabino, Dominant White, Splash)
- Grade without a color test or proof of pedigree, will be approved on an individual basis thru photos/videos by the WJR.

## **Definitions**

**Leopard**- full white body with pigmented spots

**Near Leopard**- white body, from wither to tail, with pigmented spots



**\*\* All guarantees must be approved by the WJR and may require a color test to be approved; it is at the sole discretion of the WJR to refuse this guarantee to any mare.**

**\*\*Detailed photos are required at birth to verify Mare and Foal before Stud fee will be refunded**

**THE FOLLOWIN TERMS APPLY TO ALL FEES HEIRIN:**

1. All payments will be made in U.S. Dollars via: Cash, Venmo, Cashier's Check or Wire transfer.
2. All fees must be paid and this signed Agreement (along with a copy of the Mare's registration papers (If available), and conformation Photos) delivered to WJR before any semen shall be provided.
3. The Stud Fees set within are subject to change at the discretion of WJR.
